## Storage Booking Form

Applewood Countryside Park offers secure undercover storage for caravans, motorhomes, campervans and trailer tents.

**£45.00 per calendar month**

- Applewood Countryside Park offers hard standing, undercover, secure storage with high fencing, locked gates and CCTV cameras and is accredited as a Silver CaSSOA registered site.
- Not only have you got peace of mind that your caravan is being stored securely, we also offer a tow service should you wish to stay onsite. Towing is charged at **£50.00 per visit** ensuring your unit is ready on your pitch for your arrival and safely returned to storage after your stay.
- Need access to your unit? Call Park Reception on 01953 715319 and speak to a member of the team who will happily allow you into the compound during office hours.
- Trusted traders may also be permitted access to the compound to work on your unit during office hours.

**Benefits of becoming a storage holder** - As from 1st May 2024 the new storage holder benefits will be:

- One FREE two-night stay on a standard EHU pitch to be taken in isolation or as part of a longer stay during off peak months.
- 20% off all touring pitches booked for 7 to 14 nights here at Applewood Countryside Park to be used once per calendar year.
- Pay for one night and get a second night half price during off peak months.
- Don't forget that certain caravan insurance companies offer a discount for CaSSOA Silver registered sites.

# Terms & Conditions

- Access to the storage compound is available between 9am-5pm Monday to Friday and 9am-2pm Saturday and Sunday\* (\*Apr to Sep). Access required outside of these hours must be arranged in advance with Park Reception.
- The caravan, motorhome, campervan or trailer tent in storage is NOT property of Applewood Countryside Park and as such responsibility of the unit remains with the owner.
- Applewood Countryside Park will do its utmost to protect the unit in storage, but cannot accept any blame for loss or damage incurred whilst the unit is left in storage including damage caused by vermin infestation or adverse weather conditions. The unit and all contents of the unit are left at the owner's risk therefore we advise that all personal effects and valuables are removed and windows and doors are locked securely.
- The owner agrees to insure their unit against loss or damage by fire, storm, theft, flood and third party liability whilst their unit remains in storage. The Park Manager may ask to see a copy of the insurance certificate at any time.
- Towing is charged at £50.00 per visit ensuring your unit is ready on your pitch for your arrival and safely returned to storage after your stay. Towing must be booked and paid a minimum of 7 days in advance of arrival. Please note this service is unavailable during the School Summer Holidays (19<sup>th</sup> July - 4<sup>th</sup> September 2024).
- If a cover is fitted to your unit, please ensure it does not rub on the wheels, this will help protect your cover and prevent any damage whilst towing. Applewood Countryside Park accepts no responsibility for any damage whilst towing your unit on/ off site, therefore we ask customers to ensure their insurance covers us to do so.
- All tyres must be kept road legal and to the correct tyre pressure. Applewood Countryside Park will refuse to tow any units that are deemed to be unsafe or not roadworthy.
- Legs MUST be fully wound up when leaving a van to be towed off pitch, any movers disengaged and gas cylinders disconnected.
- Applewood Countryside Park must have a labelled, spare set of keys for any security locks on the unit. This is so we can move it in case of emergency or if you would like the unit towed onto the park.
- The Park Manager will not permit the removal of any units from the storage compound by anyone other than the owner except on the prior written authority of the owner.
- You will be supplied with an A4 sign for the inside front window to ease identification whilst your unit is in storage. This MUST be displayed clearly at all times and will detail your name and the make/ model of your unit. Please ensure these are correct at all times and notify us if any alterations or replacements are required.
- All units must be kept clean, tidy and presentable whilst being stored. Applewood Countryside Park has the right to employ a cleaning company and invoice the holder should this not be met.
- We do not allow maintenance and cleaning of vans inside the storage facility unless booked with one of our trusted suppliers.
- All gas cylinders MUST be disconnected whilst your unit is in storage.
- All units and the allocated space around them must be kept tidy and no litter is to be left behind. Applewood Countryside Park will charge up to £30.00 per bag/ item left for disposal.
- We ask that you either pay a year in advance with our 1 Year Storage Pre-Payment Plan or set up a monthly standing order to ensure that your payment is with our accounts team on the 1st of every month. Your account must stay in credit at all times, this means paying a minimum of one month's storage in advance of the due date.
- Payment of any outstanding storage fees must have cleared before the unit is removed from the site. Applewood Countryside Park retains a lien on the caravan for any unpaid accounts.
- Should you wish to terminate this agreement, Applewood Countryside Park requires one full calendar months' notice.
